GK Volunteer Activity Registration

TERMS AND CONDITIONS

ELIGIBILITY

- 1. The Volunteer Activities posted in GK are open to all Philippine residents, locals and foreigners, willing to do volunteer work. A group can consist of a minimum of two (2) members. The maximum number of volunteers will depend on the particular activity. For large groups with more than ten (10) members, kindly email as at lnfo@gawadkalinga.com for a more efficient coordination. Each group member must register a mobile phone number AND/OR an email address. The group's Team Leader must be at least eighteen (18) years.
- 2. Minors who wish to join a volunteer activity can do so provided they obtain the prior consent of any parent or the guardian. The Team Leader represents and warrants that he/she has informed and obtained the prior consent of the parents or guardians of minors in (a) joining the team, (b) disclosing their mobile phone numbers and email addresses and any other information for the purpose of participating in GK Volunteerism Activities, and (c) allowing the sharing of their mobile phone numbers and email addresses to the organizer of the volunteerism activity they signed up for, for proper and efficient coordination.

The Team Leader shall be responsible for the wellbeing of the minor(s) in the group activity and its events, and ensure that the volunteer activity of the minor(s) shall not interfere with their school schedule and study hours.

CONDITIONS OF REGISTRATION

By registering, each group member and parent or legal guardian who gave consent to the participation of a minor child or ward

- a. Fully understand and accept the Mechanics, Frequently Asked Questions and the Terms and Conditions including its Privacy section; and
- b. Confirm all rights, permissions and consents necessary to grant the rights to GK as expressed herein; and

VOLUNTEERING

- 1. The group members and the parent or legal guardian who consents to the participation of the minor child or ward represent and warrant that the group members (a) consent to their being members of the group and by having the Team Leader register them as group members, (b) allow the Team Leader to enter the required personal information such as their mobile phone numbers and email addresses required on the GK portal, (c) consent to the sharing of their disclosed information to the GK event organizer, and (d) are not violating any agreement or arrangement that will prevent any one of them from participating in GK Volunteerism Activity.
- 2. The group shall identify its Team Leader who must have an active mobile phone. The Team Leader will create the account and register the group.
- 3. The Team Leader can search for existing volunteer opportunities organized by GK, its partner organizations or by other volunteers in the GK portal or create the group's own volunteer activity, subject to the approval of GK.

PRIVACY POLICY

- 1. By registering with GK, all group members and the parent or guardian who allows the participation of the minor child or ward consent to the collection, use, disclosure, transfer and processing of the personal information shared in the GK Portal for the management of the volunteerism activity.
- 2. GK may share the group members' personal information which a member inputted in the GK portal with GK's volunteer management team for proper and efficient coordination. This may involve the storage, use, disclosure or other processing or transfer of the personal information outside of the Philippines. Parties receiving the personal information shall be bound by Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012.

COOKIE POLICY

The GK portal uses cookies and by accessing the portal, a group member consents to the use of cookies.

- 1. What are cookies? Cookies are small pieces of text files sent by a browser from a website visited by said browser. Cookies allow a website to recognize a browser. They also make the browser's next site visit easier and more useful.
- 2. How does GK use cookies? By using and accessing the GK portal, GK may place a number of cookie files in the viewer's web browser. GK uses cookies to enable certain functions of the website, provide analytics, store the browser's preferences, and allow advertisements delivery, including behavioral advertising.
- 3. What about third-party cookies? GK may also use various third-parties' cookies to report usage statistics, deliver advertisements, and so on. MISCELLANEOUS

1. GK reserves the right at any time in its absolute discretion and without prior notice to the group members and parent or legal guardian who gave consent to the participation of a minor child or ward

- a. to cancel, modify, suspend or delay the implementation of GK activities;
 b.to make changes to the Mechanics, Frequently Asked Questions and Terms and
 Conditions which shall bind all groups, parents and legal guardians; or
 - c. to modify guidelines in the volunteerism activities;
- 2. GK reserves the right at its sole discretion and upon its reasonable belief to disqualify a group or any group member
 - a. tampering or attempting to tamper with the GK content, system or group entries;
 - b. violating the Mechanics and Terms and Conditions; or
 - c. engaging in any conduct that is detrimental or unfair to GK or any group or group member such as acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any person during a volunteering event;
- 3. GK has the right to bar a group member who is ineligible, whose eligibility is in question or who has been previously disqualified to continue with GK, or for any other good cause as determined solely by the GK.
- 4. In the event viruses, bugs, unauthorized human intervention, acts of God, acts or regulations of any governmental, war, national emergency, accident, fire, riot, strikes, lockouts, industrial disputes, acts of terrorism or other matters beyond GK's reasonable control corrupt, prevent or impair the administration, security, fairness or proper implementation of GK activity in such that it cannot be conducted as originally planned, GK has the right, in its sole discretion, to modify the Mechanics, Frequently Asked Questions and Terms and Conditions or to cancel, modify, terminate or suspend a GK activity.
- 5. Any attempt by any individual to damage the GK portal or undermine its legitimate operation is a violation of the Terms and Conditions and Philippine laws and should GK believe or become aware that such an attempt has been, is being, or will be made, it has the right to seek remedies and damages from any responsible individuals to the fullest extent permitted by law, including without limitation their criminal prosecution.
- 6. The Mechanics, Frequently Asked Questions and Terms and Conditions are not intended to confer rights on any third party and no third party shall have any right to enforce any provision thereof.

GOVERNING LAW AND JURISDICTION
